### Memorandum of Understanding

This Memorandum of Understanding is made on this 1<sup>st</sup> July 2023 BETWEEN

M/s. Ayush Enviro Tech Pvt Ltd is having its Plant office at Plot No.43 Karkala Padubidri Main Road Nandikur Industrial Area Nandikur Udupi Dist 574111. Here in after referred to as the **CONTRACTOR. (CBMWTF)** 

AND

M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL, (Synapse Neuro Care Pvt Ltd), Kannur Village, Padil Mangalore-575007. Hereinafter referred to as M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL.

- a. CONTRACTOR. (CBMWTF) has obtained consent and Authorization from Karnataka Pollution Control Board (KSPCB) having a common treatment facility for managing Bio Medical waste in Plot No.43, Karkala Padubidri Main Road, Nandikur Industriel Area, Nandikur, Udupi. The said facility is provided with state of Incinerator, Autoclave system along with shredder.
- b. M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL gives its bio-medical waste properly packed in color coded bags (in case of amputated parts the hospital should give one letter duly signed by authorized person mentioning the patient's name, age & reason for amputation) as per pollution control board regulations for treatment and final disposal at Plot No.43 Karkala Padubidri Main Road Nandikur Industrial Area, Nandikur Udupi. The bio-medical waste should be given at one single point by the M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL at the given time by the CONTRACTOR. (CBMWTF)
- c. This memorandum of Understanding shall be valid for Three years and M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL during this period of Three years shall not enter into any agreement with any other party or organization for the waste management, treatment and disposal.
- d. M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL has 100 (Hundred) beds. The Exact number of beds will be taken from the declaration given before the state Authorities or Physical beds whichever is higher after verification by both parties. Hospital shall not mislead the CONTRACTOR regarding the number of beds and shall clearly indicate in writing the number of additions as and when made.
- e. CONTRACTOR (CBMWTF) shall charge a price of Rs. 7/- per day per bed from 01.07.2023 to 30.06.2024 and Rs. 7.5/- per day per bed from 01.07.2024 to 30.06.2025 and Rs. 8/- per day per bed from 01.07.2025 to 30.06.2026 to as mutually agreed between the Contractor And M/s. FIRST NEURO BRAIN &SPINE, SUPERSPECIALITY HOSPITAL, transportation, treatment and final disposal of bio-medical waste.
- f. M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL is assuring that it shall make the payment regularly through Account payee cheque in favor of M/s. Ayush Enviro Tech Pvt. Ltd on or before 10th of every month.

- g. In case the M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL fails to make payment on the agreed date for any reason HCE shall arrange to make the payment before the expiry of one week from the due date. If the non-payment continues beyond one week from the due date, from the next working day the **CONTRACTOR (CBMWTF)** shall stop the collection of waste with due intimation to Karnataka State Pollution Control Board.
- h. **CONTRACTOR (CBMWTF)** will collect properly Segregated Bio-medical waste regularly and treat the waste as per the Pollution Control Board Regulations. **CONTRACTOR (CBMWTF)** will not collect any waste if it is not segregated or properly packed and further the **CONTRACTOR (CBMWTF)** also makes it clear that it will not collect general garbage Like Food waste, papers, carton boxes And Plastics rappers Etc... **CONTRACTOR (CBMWTF)** is not responsible for any usable materials (surgical instruments, Lab equipments, etc.) received along with the Bio-medical waste from your HCE.
- i. M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL if requested will supply the color coded waste collection bags at a nominal rate mutually decided between **CONTRACTOR (CBMWTF)** and **HCE**.
- j. In case of Hospital/Nursing Home/Clinics find any irregularities in collection of waste, they can send a notice in writing to **CONTRACTOR** (**CBMWTF**) for immediate action.
- k. In case of any non-collection of waste by CONTRACTOR (CBMWTF) on any day without prior intimation or valid reason, the Hospital/Nursing Home can deduct Rs. 25 (Twenty Five only) /Day as penalty on that particular day in addition to the particular Day, In case of collection of waste by next day under prior intimation or valid reason, the M/s. FIRST NEURO BRAIN & SPINE, SUPERSPECIALITY HOSPITAL may waive such penalty to the Company for that particular day.
- 1. In case of violation of any of the agreed conditions of the MOU by either side, either party shall issue notice to terminate this MOU, three months in advance. Upon such premature termination the party issuing notice for termination shall pay six months service bill to the notice.
- m. This Memorandum of Understanding will remain valid for a period of Three years commencing from 1<sup>st</sup> July 2023 to 30<sup>th</sup> June 2026, after which date the MOU automatically stands terminated by efflux of time unless extended further by mutual agreement. All disputes to this understanding are subject to the jurisdiction of the court in Mangalore only.
